**A TRIBAL RESOLUTION OF THE MUSCOGEE (CREEK) NATION OPPOSING THE FEDERAL RECOGNITION OF THE ENTITY KNOWN AS THE MUSCOGEE NATION OF FLORIDA PURSUANT TO APPLICATION BEFORE THE BUREAU OF INDIAN AFFAIRS BRANCH OF ACKNOWLEDGEMENT AND RESEARCH**

**Be it resolved by the National Council of the Muscogee (Creek) Nation:**

**WHEREAS**, the Muscogee (Creek) Nation since time immemorial has exercised the sovereign rights of self-determination on behalf of the Muscogee (Creek) people; and

**WHEREAS**, the Muscogee (Creek) Nation is a federally recognized Indian Nation with a historic and continual government-to-government relationship with the United States of America; and

**WHEREAS**, the Muscogee (Creek) Nation represents over 80,000 Muscogee citizens throughout the United States of America; and

**WHEREAS**, the Muscogee (Creek) Nation, which is the former Creek Confederacy from the Southeastern part of the United States, is composed of forty-four smaller tribal towns; and

**WHEREAS**, between 1827 and 1838, the Muscogee (Creek) Nation and all of its members were voluntarily or forcibly removed from the Southeast to Indian Territory along with other Southeast tribes on what historians refer to as the infamous Trail of Tears; and

**WHEREAS**, the Muscogee (Creek) Nation has maintained their true cultural identity in Oklahoma with 16 distinct ceremonial grounds where they hold traditional sacred ceremonies; and

**WHEREAS**, the sovereignty and reputation of the Muscogee (Creek) Nation continues to be in jeopardy due to the acts of individuals, organized groups, and cultural clubs claiming Muscogee heritage who don't have lineage verification or meet criteria for Muscogee (Creek) Nation citizenship; and

**WHEREAS**, these heritage groups and cultural clubs have sought both state and federal recognition; and

**WHEREAS**, the heritage group known as the Muscogee Nation of Florida has sought federal recognition in the past and has not met qualifications for federal acknowledgement for the existence as an Indian Tribe; and

**WHEREAS**, the Government of the Muscogee (Creek) Nation has determined that the proposed heritage group entitled Muscogee Nation of Florida is not of any relation to the Muscogee (Creek) Nation or the tribal towns it encompasses; and

**WHEREAS**, the Muscogee (Creek) Nation people have had our own distinct language, ceremony, and spiritual beliefs that have been preserved throughout hundreds of years; and

**WHEREAS**, the Government of the Muscogee (Creek) Nation has determined that the heritage group entitled Muscogee Nation of Florida has not provided acceptable documented proof that they are tied traditionally, historically, culturally, or politically to the Muscogee (Creek) Nation or Creek Confederacy, and the use of our tribal namesake is an attempt to make this heritage group associated to the Muscogee (Creek) Nation.

**NOW THEREFORE BE IT RESOLVED**, that the Muscogee (Creek) Nation National Council hereby supports the federal recognition process of the Department of the Interior as administered by the Bureau of Indian Affairs Branch of Acknowledgement and Research.

**BE IT FURTHER RESOLVED**, that the Muscogee (Creek) Nation objects to the federal recognition of the Indian heritage group known as the Muscogee Nation of Florida and urges the Bureau of Indian Affairs Branch of Acknowledgement and Research to reject the Muscogee Nation of Florida's request for acknowledgment.




