RESULTS OF THE OCTOBER 1, 2024, SECRETARIAL ELECTION OF THE CALIFORNIA VALLEY MIWOK TRIBE

TO: ELIGIBLE VOTERS THE CALIFORNIA VALLEY MIWOK TRIBE

The proposed Constitution of the California Valley Miwok Tribe was submitted to the registered voters of the California Valley Miwok Tribe at a Secretarial election held on October 1, 2024, to adopt or reject the proposed Constitution in accordance with section 16 of the Indian Reorganization Act of June 18, 1934 (45 Stat. 984), as amended and the Code of Federal Regulations, Part 81 (25 C.F.R. 81).

In accordance with 25 C.F.R. § 81.42, the Results of the Secretarial election is hereby posted at the following locations: (1) Bureau of Indian Affairs, Central California Agency, 650 Capitol Mall, Ste. 8-500, Sacramento, California, 95814; and (2) California Valley Miwok Tribe – Organization Information Indian Affairs (<https://www.bia.gov/regional-offices/pacific/central-california-agency/cvmt>).

Pursuant to 25 C.F.R. § 81.43, “Any person who was listed on the California Valley Miwok Tribe Eligible Voters List and who submitted a voter registration form may challenge the results of the Secretarial election.” The written challenge, with substantiating evidence, must be received by the Chairperson of the Secretarial Election Board, Bureau of Indian Affairs, Central California Agency, 650 Capitol Mall, Suite 8-500, Sacramento, California 95814, by 4:30 p.m. October 7, 2024. Challenges received after the October 7, 2024, deadline for filing challenges will not be considered.

Under a Secretarial Election authorized by Amy Dutschke, Pacific Regional Director, on June 21, 2024, the attached Constitution of the California Valley Miwok Tribe, California, was submitted to the registered voters of the Tribe and on October 1, 2024 was duly adopted rejected by a vote of 137 for and 0 against and 11 cast ballots found spoiled in an election in which at least thirty percent (30%) of the 174 registered voters cast their ballot in accordance with the Indian Reorganization Act of June 18, 1934 (48 Stat. 984, 25 U.S.C. § 5123), as amended.
