FY 2024 Annual Awards Program (\$120M)

- The Branch of Tribal Climate Resilience is soliciting proposals through its Annual Awards Program to support federally recognized Tribes and Tribal organizations
- \$120M available for FY24 to support Tribal climate resilience
- Final year of increased funding made possible through the Bipartisan Infrastructure Law and Inflation Reduction Act

FY 2024 Annual Awards Program (\$120M)

- Projects may address current and future climate change impacts on Tribal Treaty and Trust resources, economies, agriculture, food sovereignty, conservation practices, infrastructure, and human health and safety
- TCR and this funding opportunity support Tribal sovereignty, self-determination, and inclusion of Indigenous Knowledges

The TCR is committed to equity and environmental and social justice in its program delivery and seeks to ensure that all projects provide direct, meaningful benefits consistent with Executive Order 14112 – *Reforming Federal Funding and Support for Tribal Nations To Better Embrace Our Trust Responsibilities and Promote the Next Era of Tribal Self-Determination*, the Justice40 Initiative, DOI’s policy on the inclusion of Indigenous Knowledge (301 DM 7), DOI’s Equity Action Plan, and other related policies and initiatives.

Key Dates

- **July 17 – October 18, 2024 - OPEN APPLICATION PERIOD**
- **Friday, October 18, 2024 - DEADLINE TO SUBMIT APPLICATIONS**
Applications must be submitted no later than 7:59 pm Alaska time/11:59 pm Eastern time. Proposals received after this deadline cannot be considered.
- **January 2025 - FUNDING SELECTIONS ANNOUNCED**

Eligibility

- 1) Federally recognized Tribes are defined as those listed in the current Federal Register (*Notice of Indian Entities Recognized and Eligible to Receive Services from the United States Bureau of Indian Affairs, 89 Fed. Reg. 944 (Jan. 8, 2024)*).

- 2) Authorized Tribal organizations and Tribal consortia as defined in the Indian Self-Determination and Education Assistance Act at 25 U.S.C. § 5304(I).

Note that these do not include Alaska Native Corporations or State recognized Tribes.

Applicants must be eligible to receive funding via Public Law 93-638 Indian Self-Determination and Education Assistance Act (ISDEAA) contracts and compacts.

Other entities may be eligible to receive funding as sub awardees or contractors.

FY24 Categories of Funding

Category 1 – Planning (\$250,000 maximum)

Category 2 – Implementation (\$4,000,000 maximum)

Category 3 – Relocation, Managed Retreat, Protect-in-Place
(RMP) Staff

(\$150,000/year for 3 years; \$450k total)

**Applicants may only receive one award per category. If multiple proposals are submitted, only the highest-ranking proposal would be considered for funding.*

IMPORTANT: Tribes previously awarded RMP Coordinator Category funds from TCR are ineligible for Category 3.

Category: 1 (Planning)

Funding: \$250,000 maximum (competitive)

Eligibility: All Federally recognized Tribes, authorized Tribal organizations (including Tribal consortia)

Examples:

- Risk Assessments
- Climate adaptation plans
- RMP plans
- Natural or cultural resource management plans
- Forest, fire, rangeland, or wetland management plans
- Hazard/emergency response or mitigation plans
- Ecological restoration
- Greenhouse gas mitigation plans
- Construction or engineering plans/designs
- Training and workshops
- Internships/climate staffing or program development (i.e., capacity building)
- Youth & community engagement

Category: 2 (Implementation)

Funding: \$4,000,000 maximum (competitive)

Eligibility: All Federally recognized Tribes, authorized Tribal organizations (including Tribal consortia)

- Category 2 awards support the execution of climate resilience projects previously identified and supported by official planning documents
- Examples of supporting planning documents include (but not limited to): Tribal climate adaptation plans, relocation master plans, natural resources plans, drought plans, hazard mitigation plans, ecological restoration plans, greenhouse gas mitigation plans, and construction or engineering plans/designs.
- Construction activities may require compliance with Subpart J (for Self Determination Contracts) or Subpart K (for Self Governance compacts)

Category: 3 (Relocation, Managed Retreat, Protect-in-Place Staff)

Funding: \$150,000 max per year for 3 years (\$450k total)

Eligibility: Federally recognized Tribes^{1,2}

¹Tribal organizations/consortia are ineligible as primary awardees. ²Tribes previously awarded RMP Coordinator position funds from TCR are ineligible.

- Category 3 awards are non-competitive funding intended to support Tribes with limited staff or technical or project management capacity and who have imminent relocation, managed retreat, or protect-in-place needs due to climate impacts.
- RMP staff positions may focus on development of community planning documents, climate adaptation strategies, implementation actions, community engagement, coordination with federal and other partners, emergency response plans or mitigation, and implementation of RMP actions.

Category: 3 (Relocation, Managed Retreat, Protect-in-Place Staff)

Funding: \$150,000 max per year for 3 years (\$450k total)

Eligibility: Federally recognized Tribes^{1,2}

¹Tribal organizations/consortia are ineligible as primary awardees. ²Tribes previously awarded RMP Coordinator position funds from TCR are ineligible.

- Includes access to a climate resiliency cohort training module for the staff position.
- Training module is ten-month long series (in Year 1) and consists of peer-to-peer learning and knowledge exchange regarding climate resiliency and RMP decision-making facilitated by BIA and the Institute for Tribal Environmental Professionals (ITEP).
- Participation in the training module is required for all Category 3 awardees.
- *Please note, while this is a non-competitive category, funding requests may exceed available funding. Communities which are at highest risk, as supported by published documentation will be prioritized for funding from this Category*

1. Application Form (see page 5 of Solicitation for example)
2. Cover Letter (indicating leadership acknowledgement/support for the application)
3. Project Proposal¹ (6-page limit, scored 0-100 points)
4. Budget (template available on TCR Website; NO IDC)
5. Budget Narrative
6. Optional: Supporting Documents (does not count towards 6-page limit)

¹Category 3 (RMP Staff) requires a completed questionnaire in lieu of a project proposal.

PROJECT SUMMARY: (A brief summary to be made public, if awarded. The summary should focus on what the project will accomplish including the benefits and impacts and should be two sentences long in most cases. The first sentence should clearly state the main activity being used to address the specific need. The second sentence should state the expected outcome from the investment and relevance to climate resiliency. The summary should be concise and use clear, straightforward language that can be easily understood by a diverse audience. Please refrain from using pronouns such as I, we, our, etc.)

Budgets

1. Costs disallowed under ISDEAA cannot be funded, see *2 C.F.R. Part 200, Subpart E – Cost Principals* for standard disallowed costs.
2. Do not include indirect costs in budgets. All indirect or administrative support will be paid separately, in the form of Contract Support Costs or CSC, which comes from separate funding and is paid in addition to any funds received from TCR.
3. Clearly identify any pass-thru/contractor/sub awardee costs

Purpose: The Branch of Tribal Climate Resilience (TCR) is soliciting proposals through its Annual Awards Program to support federally recognized Tribes and Tribal organizations as they address current and future climate change impacts on Tribal Treaty and Trust resources, economies, regenerative agriculture, food sovereignty, conservation practices, infrastructure, and human health and safety. This year, \$120M is available and is the final year of increased available funding made possible through the Bipartisan Infrastructure Law and Inflation Reduction Act.

Category 2: Implementation (\$4,000,000 maximum)
