**Subject:** MEETING CHANGE ANNOUNCEMENT: PROGRESS Act Negotiated Rulemaking Committee

Committee Members,

As published in the Federal Register, the PROGRESS Act Negotiated Rulemaking Committee was originally scheduled to convene next week on January 30-February 2, 2023, in Washington, DC, for their first in-person meeting. Although the Federal and Tribal subcommittees have been diligently working to reach consensus on provisions to be considered by the full Committee, there has arisen a need for some additional time for the subcommittee to review and advance a response to the proposed subparts that have been exchanged. Therefore, the Leadership Team met and decided to convert the January 30<sup>th</sup> – February 2<sup>nd</sup> hybrid (in-person with a virtual option) meeting that was originally scheduled for next week in Washington, DC to a virtual-only meeting forum. The Leadership Team believes this would be the most efficient and cost-effective option as well as the most productive use of the Committee/Subcommittee’s time.
